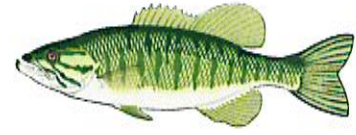




# LAKE CHELAN OPEN

**Entries:** Due June 3rd, by 5:00 a.m.  
**Off Limits:** May 30<sup>th</sup>, May 31<sup>st</sup> and June 1st  
**Prefish all day:** June 2nd Friday is ok.  
**Launch Site:** Mill Bay Park, on the north shore of Lake Chelan  
 Across from Mill Bay Casino  
**Check-In:** Mill Bay Park on Sat., June 3rd 5:00 am.

**Driver's Meeting:** June 3rd at 5:15 a.m.  
**Blast Off:** Immediately after driver's meeting and position draw on each day. ( Note the time change as we are going to get out as early as possible.)

**Weigh-In:** Mill Bay Park at 3:00 p.m., June 3rd and 2:00 p.m. on June 4th

**Requirements:** Aerated livewell, kill switch, life vests and a good attitude!  
**Pay Back:** 80% on entry fees, 100% on option pot and big fish

The first weekend in June will be great fishing on Lake Chelan. We will have smallmouth bass in all three stages, prespawn, spawn and postspawn depending on how far uplake you fish.
